Presentation of the 2025 Financial Budget

Chief Financial Officer, Paul Rogers

Paul presents the 2025 financial budget to the board and general public. A price increase of 5% will be implemented across the board on January 1, 2025. We are expecting a clinical growth of 4%. The EMS levy increase will amount to \$3.3 million. We will be focusing on replacing 20% of contracted labor with full time staff, decreasing labor costs by an expected \$304k. An FDA grant is expected to cover \$2.5 million towards the purchase of a \$3.8 million HVAC unit.

The 2025 operating budget forecast shows a surplus of \$1,724,573. Large items include a 4% inflation loss of \$1.8 mil and EMS levy gains of \$3.3 mil. Total patient revenue is budgeted to be \$342,459,359 in 2025. Total operating revenue is

forecasted to be \$145,470,485. Total surplus is forecast to be \$1,724,573. Utilization

statistics show a total surgeries total of 2,340. Total clinics show 86,482.

Commissioners express the need to have a line item for Oncology to show statistics for

that department. Commissioner Richardson expresses the need for the commissioners

to know which departments are making a profit and which are losing money so that

they can use that information to evaluate hospital needs.

The 2025 Capital Budget shows a total capital expenditure of \$8,070,715. With the

FDA grant accounting for \$2.5 million of that, the net capital outlay is \$5,570,715.

Several commissioners express enthusiasm over the plans to replace the phone

system, which many patients have expressed frustration with.

This finance presentation will go to the Finance Committee next Wednesday, and then

will be voted on by the board at the board meeting on Thursday, November 21st.
